


#### TEST METHOD

The test method conformed explicitly with the requirements of the ASTM Standard Test Method for Sound Absorption and Sound Absorption Coefficients by the Reverberation Room Method: ASTM C423-09a and E795-05. Riverbank Acoustical Laboratories has been accredited by the U.S. Department of Commerce, National Institute of Standards and Technology (NIST) under the National Voluntary Laboratory Accreditation Program (NVLAP) for this test procedure (NVLAP Lab Code: 100227-0). A description of the measuring procedure and room qualifications is available separately.

### **DESCRIPTION OF THE SPECIMEN**

The test specimen was designated by the manufacturer as #22 - N3 Web Perforated Metal Deck - 0.75pcf Fiberglass 3.25"x3" - 2" Poly ISO Board. A visual inspection by Riverbank staff verified the manufacturer's description, further disclosing a fluted metal deck profile with perforations in the web sidelaps only. Strips of un-encapsulated 0.75 pcf fiberglass insulation (3.25 in. wide by 3.0 in. thick) were inserted into the entire length of each web. The entire metal deck specimen was backed by 2 inch thick polyisocyanurate roof board (rigid foam panels with reinforced felt facing).

The specimen consisted of 3 pieces laid as a single rectangular patch. The overall dimensions of the specimen as measured were 2.74 m (108.00 in.) wide by 2.49 m (98.00 in.) long and 127.00 mm (5.00 in.) thick. The area used in the calculations was  $6.83 \text{ m}^2$  (73.50 ft<sup>2</sup>). The weight of the entire specimen as measured was 88.57 kg (195.25 lbs), an average of 12.99 kg/m<sup>2</sup> (2.66 lbs/ft<sup>2</sup>).

The specimen was tested in the laboratory's 292.0 m<sup>3</sup> (10,311.0 ft<sup>3</sup>) test chamber. The room temperature at the time of the test was  $21\pm0^{\circ}$ C ( $70\pm0^{\circ}$ F) and  $63\pm0^{\circ}$  relative humidity. The barometric pressure was 741 mm of mercury.




Figure 2 - Acoustical perforation detail (supplied by client).

#### TEST RESULTS (Continued)

The sound absorption average (SAA) is defined as a single number rating, the average, rounded to the nearest 0.01, of the sound absorption coefficient of a material for the twelve one-third octave bands from 200 through 2500 Hz, inclusive.

The noise reduction coefficient (NRC) is defined from previous versions of this same test method as the average of the coefficients at 250, 500, 1000, and 2000 Hz, expressed to the nearest integral multiple of 0.05.


